Table with 2 columns: Registration details, Cost. Rows include HNBA members paying prior to December 1, 2008; HNBA members paying AFTER December 1, 2008; Non-HNBA members paying prior to December 1, 2008; Non-HNBA members paying AFTER December 1, 2008; and Booths canceled after January 15, 2009.

Home Show Exhibitors ONLY: To have your business cards included in Attendee binder, include \$50.00 plus 300 business cards. Business cards must be received by the HNBA office prior to January 23, 2008.

Rules for participation: All exhibitors must comply with the following rules or be subject to a \$100 fine.

- 1) Full payment and Certificate of Insurance are required at time of registration.
2) Set-up must be completed by Saturday at 8:30 AM.
3) Booths must be staffed at all times, with the exception of brief restroom breaks.
4) No beverage or food (except small candy) may be distributed from booths.
5) No early teardown.
6) Exhibitors must furnish own tables, chairs and extension cords - none are available on-site.
